# **Privacy Policy**

Protecting your private information is our priority. This Statement of Privacy applies towww.247Help.org, and 24/7 Help app and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to 24/7 help include www.247help.org.The 24/7 help website is a information and service site. By using the 24/7 help website, you consent to the data practices described in this statement.

### Collection of your Personal Information

In order to better provide you with products and services offered, 24/7 help may collect p highly personally identifiable information, such as your:

- First and Last Name
- E-Mail Address
- Phone Number

If you purchase 24/7 help's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

24/7 help may also collect anonymous demographic information, which is not unique to you, suchas your:

- Age
- Gender
- Height

Please keep in mind that if you directly disclose personally identifiable information or personallysensitive data through 24/7 help's public message boards, this information may be collected andused by others.

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to usecertain products or services. These may include: (a) registering for an account; (b) entering asweepstakes or contest



sponsored by us or one of our partners; (c) signing up for special offers from selected third parties; (d) sending us an email message; (e) submitting your credit card or other payment information when ordering and purchasing products and services. To wit, we will use your information for, but not limited to, communicating with you in relation to services and/or products you have requested from us. We also may gather additional personal or non-personal information in the future.

### **Use of your Personal Information**

24/7 help collects and uses your personal information to operate and deliver the services youhave requested.

24/7 help may also use your personally identifiable information to inform you of other products orservices available from 24/7 help and its affiliates.

### **Sharing Information with Third Parties**

24/7 help does not sell, rent or lease its customer lists to third parties.

24/7 help may, from time to time, contact you on behalf of external business partners about aparticular offering that may be of interest to you. In those cases, your unique personally identifiableinformation (e-mail, name, address, telephone number) is transferred to the third party. 24/7 helpmay share data with trusted partners to help perform statistical analysis, send you email or postalmail, provide customer support, or arrange for deliveries. All such third parties are prohibited fromusing your personal information except to provide these services to 24/7 help, and they are required to maintain the confidentiality of your information.

24/7 help may disclose your personal information, without notice, if required to do so by law or inthe good faith belief that such action is necessary to: (a) conform to the edicts of the law or complywith legal process served on 24/7 help or the site; (b) protect and defend the rights or property of24/7 help; and/or (c) act under exigent circumstances to protect the personal safety of users of24/7 help, or the public.

#### Tracking User Behavior

24/7 help may keep track of the websites and pages our users visit within 24/7 help, in order todetermine what 24/7 help services are the most popular. This data is used to deliver customized content and advertising within 24/7 help to customers whose behavior indicates that they are interested in a particular subject area.

### <u>Automatically Collected Information</u>

Information about your computer hardware and software may be automatically collected by HotSocial. This information can include: your IP address, browser type, domain names, access timesand referring website addresses. This information is used for the operation of the service, tomaintain quality of the service, and to provide general statistics regarding use of the 24/7 helpwebsite.

#### **Use of Cookies**

The 24/7 help website may use "cookies" to help you personalize your online experience. Acookie is a text file that is placed on your hard disk by a web page server. Cookies cannot beused to run programs or deliver viruses to your computer. Cookies are uniquely assigned to you, and can only be read by a web server in the domain that issued the cookie to you.

One of the primary purposes of cookies is to provide a convenience feature to save you time. Thepurpose of a cookie is to tell the Web server that you have returned to a specific page. Forexample, if you personalize 24/7 help pages, or register with 24/7 help site or services, a cookiehelps 24/7 help to recall your specific information on subsequent visits. This simplifies the processof recording your personal information, such as billing addresses, shipping addresses, and so on.When you return to the same 24/7 help website, the information you previously provided can beretrieved, so you can easily use the 24/7 help features that you customized.

- Detect security incidents, protect against malicious, deceptive, fraudulent, or illegalactivity; or prosecute those responsible for that activity;
- Debug to identify and repair errors that impair existing intended functionality;
- Exercise free speech, ensure the right of another consumer to exercise his or her rightof free speech, or exercise another right provided for by law;
- Comply with the California Electronic Communications Privacy Act;
- Engage in public or peer-reviewed scientific, historical, or statistical research in thepublic interest that adheres to all other applicable ethics and privacy laws, when ourdeletion of the information is likely to render impossible or seriously impair theachievement of such research, provided we have obtained your informed consent;
- Enable solely internal uses that are reasonably aligned with your expectations based onyour relationship with us;



- · Comply with an existing legal obligation; or
- Otherwise use your personal information, internally, in a lawful manner that iscompatible with the context in which you provided the information.

#### Children Under Thirteen

24/7 help does not knowingly collect personally identifiable information from children under theage of thirteen. If you are under the age of thirteen, you must ask your parent or guardian forpermission to use this website.
